## **PRODUCT DESCRIPTION:**

The Fiberglass Fabric Reinforcement is a reinforcing fabric composed of highly flexible woven fiberglass yarn.

It is used on the exterior of the control joint from the top of the footer up to the grade line.

## **PURPOSE:**

To protect the Control-Joints created in foundation walls. The Fiberglass Fabric Reinforcement works in conjunction with the Waterstop Elastomeric Sealant and together they create a watertight seal on the outside below-grade that resists hydrostatic pressure.

## **ADVANTAGES:**

- Resistant to rot and water damage
- High tensile strength
- Acid and alkali resistant
- Compatible with asphalt or tar and all accepted waterproofing and coating compounds

## **APPROXIMATE USAGE:**

One roll - App. 18, 8' Control Joints

## **PREP/APPLICATION:**

Remove the reusable plastic extrusions used to create Control-Joints in the foundation. Follow the instructions for the application of the Waterstop Elastomeric Sealant.

Then press the Fiberglass Reinforcement Fabric into the Waterstop Elastomeric Sealant before curing occurs. It is applied on the exterior of the control joint from the top of the footer to the grade line.

## **CLEAN UP:**

Place all excess fabric into trash.
