The 1800 Mastic is a single component, hydrocarbon polymer, elastomeric compound.

**PREP/APPLICATION:**

All surfaces should be free from oil, grease, rust, dirt and any other debris. Apply directly to any surface flaw with a trowel or putty knife.

**CLEAN UP:**

Use Marflex's Orange 90 cleaner.

**PRODUCT HANDLING/STORAGE:**

- Do not thin
- Do not use near open flame, sparks or ignition sources
- Avoid breathing solvent fumes
- Avoid prolonged contact with skin
- Keep container closed when not in use
- Unlimited shelf life if properly stored
